## **ENDORSEMENT CRITERIA**

In order to achieve the FCANZ Accredited Fencing Contractor business endorsement, applicants must meet the following requirements:

#### FCANZ Current General Member

Accredited Fencing Contractors must have held a current General membership with the Fencing Contractors Association NZ for at least 2 years.

#### NZQA National Certificate in Fencing Level 4

One of the Principals of the business must have completed the NZQA Certificate in Fencing Level 4.

#### **Employer/Client Testimonials**

Three current testimonials (dated within 6 months) from clients (including full contact details), with permission to contact the clients.

#### Signed Declaration

Signed declaration and agreement to comply with the Accredited Fencing Contractor programme, FCANZ Member Code of Ethics and Conduct; and Standards.

#### Must also provide evidence of:

- A minimum of three years in business.
- A current First Aid Certificate held by the principal or a nominated employee.
- Health and Safety pre-qualification from SHE Docs, Sitewise, PREQUAL or other recognised industry pre-qualification system. Pre-qualification evidence must be a 75% or higher rating overall for health and safety systems and practice.
- Employment contracts (if workers employed).
- Evidence of worker training.
- Sub-contractor contracts (if used).
- Public Liability Insurance (minimum \$2 Million).
- Attendance at two FCANZ Best Practice Days and/or FCANZ webinars, and one FCANZ Conference within the previous five-year period.

#### On-site visit from authorised FCANZ auditor

- Evidence of quality workmanship at a minimum of 2 job sites over the past 2 years.
- Evidence of quality workmanship to industry best practice on a current worksite (regional variances taken into consideration).
- Physical evidence of worker training to industry best practice standards (if workers employed)
- Evidence of machinery maintenance
- Evidence of a working Health and Safety policy



## **ENDORSEMENT INVESTMENT**

An initial non-refundable fee of \$300.00 + GST is payable upon application. When accepted, a further fee of \$675.00 + GST (including travel) is payable prior to the onsite visit and certification. An annual renewal fee of \$50.00 plus GST is payable to maintain endorsement. The applicant's annual FCANZ membership must also remain current.

#### Five-year Audit

Accredited Fencing Contractors will be audited after five years by providing updated documents to evidence certification criteria and an onsite inspection. Spot audits may take place within the five-year period.

Five-year renewal fee \$675.00 + GST.

## **ENDORSEMENT TERMS & CONDITIONS**

- Accredited Fencing Contractors agree to abide by the FCANZ Member Code of Ethics and Conduct.
- 2. Accredited Fencing Contractors are to uphold industry best practice and high standards of fencing throughout their business, including workers and subcontractors (if employed).
- 3. Accredited Fencing Contractors will comply with all legal requirements of running a business. And endeavour to do so in an ethical manner.
- 4. Any decision relating to endorsement status is the full and final decision of the FCANZ Review Panel.
- 5. Should the Review Panel be unable to make a decision, further evidence may be requested, or another site visit at the Contractors' cost may be required.
- 6. The on-site audit will, at minimum, include all aspects of the FCANZ inspection checklist (above).
- 7. Accredited Fencing Contractors agree to follow the FCANZ brand guidelines.
- 8. Accredited Fencing Contractors agree to annually provide FCANZ with their current Public Liability Insurance Certificate, First Aid Certificate and H&S Prequalification Certificate.
- Accredited Fencing Contractors will refrain from using the Accredited Fencing Contractor logo and status should their membership or endorsement cease or be removed.
- 10. On the sale of the business, the Accredited Fencing Contractor status cannot be transferred to the new business owner unless it is to someone who can provide evidence that they were working in the business for a minimum of three years prior to the sale and holds NZQA level 4 National Certificate of Fencing.
- 11. If the Accredited Fencing Contractor business becomes involved in a legal dispute or becomes insolvent, they must notify FCANZ within 5 working days of the notification.

On-site audit	Auditor	<ul> <li>Complete the audit form and collect photographic evidence, sighting physical works, training register, and vehicle/machinery maintenance register.</li> <li>Seek more details if required or provide guidance on corrective actions (if required).</li> <li>Provide a recommendation to the review panel.</li> </ul>
Decision	Review Panel	Review auditor's report and make a decision.
Notify	Administration Manager	<ul> <li>Notify the applicant of the outcome and any corrective actions</li> <li>Arrange for additional audit (at the applicant's cost) if required</li> </ul>
